**2007 SAN ANTONIO SPEEDWAY (SAS) SEASON DRIVER PARTICIPANT AGREEMENT,
RELEASE AND WAIVER OF LIABILITY AND INDEMNITY**

I have elected to participate in San Antonio Speedway event(s) at my own risk and accept all risk and outcomes of participating in that event, no matter what might occur during the entirety of that event including traveling to and from the event and during setting up, practice, qualifying, racing and post race activities.

I understand automobile racing is a dangerous sport and can lead to injuries, permanent or otherwise, or death, and I and my representatives, kin, heirs, assigns and next of kin hold harmless and hereby release and waive San Antonio Speedway, its officers, shareholders, employees, officials and sponsors during any SAS events of any responsibility for death, injury, property damage, or monetary damage that might occur, and discharges and covenants not to sue San Antonio Speedway, its officers, shareholders, employees, officials and sponsors no matter what the cause of death, injury, property damage or monetary loss.

I have acknowledged and have advised my representatives, kin, heirs, assigns and next of kin that motor racing is a dangerous sport and I have elected to participate in the sport knowing the risk involved and have elected to waive certain rights as outlined in the above paragraph and hereby assume full responsibility for and risk of bodily injury, death or property damage due to the negligence or gross negligence of the San Antonio Speedway, it's officers, shareholders, employees, officials and sponsors during any aspect of a San Antonio Speedway event.

I acknowledge and agree and understand this foregoing release, waiver and indemnity agreement is intended to be as broad as possible and inclusive as is permitted by law of the state in which the event occurs and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal effect.

I will follow and abide by all SAS rules, both written and oral, accepting any ruling, interpretation of rules, fines (s) and or punishment(s) from San Antonio Speedway officials for their ruling concerning any rule violation or conduct infraction. I further understood all rulings are final and are not subject to review, challenges or lawsuits.

I understand racing is a dangerous sport and take full responsibility to prepare and drive a safe race car and provide all personal safety gear and assure it is in proper working condition no matter what is in the San Antonio Speedway rules. I elect to provide what I think is necessary for my own safety.

I will insure my crew and I will abide by the San Antonio Speedway rules and conduct expectations and accept any sanctions brought upon myself from San Antonio Speedway.

I am responsible for my crew conduct and assume all liability for crew conduct.

I have read the above paragraphs in their entirety and understand that it is my responsibility to comprehend their meaning. I understand that in plain English it means that I, or anyone I am related to, or anyone I am associated with, will not sue or bring legal action against the San Antonio Speedway, it officers, shareholders, employees, officials and sponsors under any circumstances.
